The detailed addresses of the 35 testing Labs and contact details will be shared separately through mail after placement of Contract.
- 2. Interested bidders are required to sign "Bid Security Declaration" accepting that if they withdraw or mod ify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids docu ment, they will be suspended for the period of 1 year from being eligible to submit Bids for contracts with the entity that invited the Bids.

The transit risk in this respect shall be covered by the Supplier by getting the stores duly insured. The insurance cover shall be obtained by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee. (b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the insurance will be got extended by the supplier at their cost till the successful installation, testing, commissioning and handing over of the goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the site to the supplier by the consignee, such extensions of the insurance will still be done by the supplier, but the insurance extension charges at actual will be re imbursed. (c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be insured in favour of the Director, ICMR-National Institute of Epidemiology, Chennai, covering all risk

- 15. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time fra me(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to other rights an d remedies available to the purchaser/consignee under the contract, deduct from the contract price, a s liquidity damages, calculated individually on each delayed performance of the contract including del ivery, installation, non-submission of documents, etc. a sum equivalent to 0.5% per week of delay or p art thereof until actual delivery or performance subject to a maximum of 10% of the contract price. On ce the maximum is reached purchaser may consider termination of the contract. Since the Liquidated damages are in virtue of non-performance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier.

- 18. - 27. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the sc reenshot of GST portal confirming payment to GST.
