4. 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific ATC

1. An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

2. GST Certificate should be registered in TAMILNADU. (Documentary Evidence should be submitted)
3. Registered Office should be located in Chennai District / Tiruvallur District / Kanchipuram District / Chengalpattu District (Proof of GST mentioning office address should be submitted)
4. Bidder should have the valid labour license. (Documentary Evidence should be submitted)
5. Bidder should submit Shram Suvidha CLC annual return [2025-2026] latest copy. (Documentary Evidence should be submitted)
6. The Service provider should submit ESIC Registration Certificate and EPF Registration Certificate.
7. The bidder must submit the signed copy of the ATC Acceptance.

13. The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration
14. The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
15. Payment of salary to contractual staff should be made on or before 5th of every month.

39. The Service Provider is required to have at least 40 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the 9 / 11 bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.
40. Pay Slip should be provided to contractual staff and the same should be submitted to this office along with the bill.
41. The remittance towards ESIC and EPF should be submitted every month along with the bill submitted for payment.
42. Failure of the successful bidder in providing performance security and / or returning contract copy duly signed shall make the bidder liable for forfeiture of its EMD.
43. A list of Housekeeping supervisor and Housekeeping staff along with their photographs attested by the agency including permanent address should be provided to the office for record before taking over the charge of Housekeeping services.
44. Security money of the service provider will be forfeited in case of breach of any conditions stipulated in the tender.

46. a. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
